#### January Maintenance Report

P Lemar reports ARC High Dusting-\_Staff have gone room by room at the ARC to dust the high surfaces. The exposed I beams and duct work leave a lot of areas for dust to gather over the year. Staff will continue to do the dusting yearly in the winter when the building is less occupied. <u>ARC Painting –</u> Staff have patched any holes in the walls and put a fresh coat of paint on the walls in the multipurpose rooms. We have also painted the gym. These are the two highest used rooms in the building that receive the most scuffs and damage to the walls. We repaint the rooms every winter to help keep them looking good. Ballfield Machine Update – The new ballfield machine is scheduled to be delivered on Friday January 13<sup>th</sup>. It has been a long wait for the machine but we are very happy that we will receive it before the start of the season in March. The ballfield machine is one of, if not the most, used piece of equipment that we own. It is used several hours a day from March through October. Batting Cage Netting – The netting on the batting cage at Memorial Park is stretched out and has several large holes in it. Staff will be replacing the netting this spring with new netting. The new netting is ordered and should arrive in the next few weeks. Picnic Table Painting- Staff will be bringing in and painting all of the picnic tables throughout the district. We do this every winter so that we start the season with nice looking graffiti free tables. We have several that we leave in the yard at the shop so when ones in the park get graffiti on them we can quickly replace them.
