DIRECTORS REPORT

E. Jung reports that we had the first staff meeting with Hitchcock. They prioritized our ideas into the Master Plan. SWSRA meeting was today and they mentioned that Dolton Park District was interested in joining and Palos Park is still in the works.

RECREATION REPORT

J Yuska reports we are continuing to be very busy. Don Villalobos our Athletic Supervisor has resigned. We have that position posted. Our T-Ball program is maxed out and we had a waiting list. High School soccer leagues, pre-K graduation and Day Camp is all happening now with signups. Senior Prom with the village is this Saturday. Fall/Winter brochure is being worked on currently. Splash Pad opens on 6/5/23, and our Anniversary celebration is Saturday 6/24/23.

MAINTENANCE REPORT

Sprinkler Repair- The two sprinkler heads located in the turf entrance vestibule that froze and broke last winter have been replaced. The contractor ran new lines from inside the turf to help prevent them from freezing again. The insulation that was not installed above the vestibule has not been remediated so there is a chance that this will happen again. Gate Opener- Staff have run the electric and poured a cement pad for the new gate opener. Once the concrete cures for two weeks the contractor will come out and install the new opener. Staff estimates that doing this work in-house saved the district around \$2,000. Splash Pad-Staff have got the splash pad all set for the season. All winterizing caps and plugs were removed. All lines have been flushed out to remove any residual antifreeze, and the spray features have been installed. We will be tweaking the flow to the features to try and minimize the amount of water used. Turf Leveling and Aerating- Field Turf will be out the week of May 15th to level and aerate the field turf. This is something that should be done every two to three years. The contractor will come in and fill any low spots and use a machine to aerate the turf. This will keep the field from getting compacted and will stand the "grass" back up. 2008 F250- The 2008 Ford F250 is no longer in working condition and I recommend that we sell it. It has not been used in over a year. The original plan was to trade it in along with the 2010 Ford Escape last year and purchase a new F150 or Escape but that didn't happen. The vehicle is only losing value every day that it sits in our yard so I recommend that we sell it now, or trade it in for the purchase of a new vehicle.

ATTORNEY REPORT

Mr. Miner reports that Dave Freeman spoke to Ed about the board vacancy, Raday lodge, the decennial committee, and the disposal of personal property ordinance. Mr. Miner spoke to Ed about the issue in the park when the police were called and he is waiting to hear more on that.
